Resolution 14-17: RESOLUTION OF THE CITY OF EVANSTON, WYOMING SUPPORTING THE SUBMISSION OF AN APPLICATION FOR A WYOMING CULTURAL TRUST FUND GRANT BY THE EVANSTON URBAN RENEWAL DISTRICT TO OBTAIN FUNDS TO PROVIDE SEATING FOR THE STRAND THEATER.

WHEREAS, there are Wyoming Cultural Trust Fund Grants which can be used to restore and repair historical structures such as the Strand Theater located in Evanston's Historic Downtown District;

WHEREAS, the Evanston Urban Renewal Agency will submit an application for a Wyoming cultural Trust Fund Grant to obtain funds which it intends to use to provide seating for the strand Theater; and

WHEREAS, the Public benefit of this Project is to develop and promote a strong cultural/arts center in the heart of Evanston's downtown, thus creating a more robust and vibrant local economy;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF EVANSTON, WYOMING THAT:

Section 1: The City of Evanston supports the submission of an application for a Wyoming Cultural Trust Fund Grant by the Evanston Urban Renewal Agency to obtain funds to provide seating for the Strand

Theater.
